Bath Township Zoning Fee Schedule

WHEREAS, the Bath Township Board of Trustees as authorized in the Bath Township Zoning Resolution 901.1b, may establish a schedule of fees for issuing Zoning Permits, appeals, variances, conditional use permits, processing amendments, and any other zoning actions requiring postage, legal advertising, inspections, or general process of applications;

NOW THEREFORE BE IT RESOLVED BY THE BATH TOWNSHIP BOARD OF TRUSTEES THAT the following fee schedule will be utilized:
