**Rules/Regulations**

**Article I – Cemetery General Policy**

**Section 1 – General**

- Byron Cemetery is maintained and operated as a non-profit ground and mausoleum interment facility & is nonsectarian.
- Cemetery shall have the right to: enforce rules & regulations; change rules & regulations without notice; correct any errors.
- Cemetery shall have the right to remove offensive memorials/decorations.
- Cemetery is open from dawn to dusk.
- Purchaser must show proof of residency to be eligible for resident pricing.
- “Owner” shall mean the owner of rights of interment.

**Section 2 – Visitations**

- Cemetery grounds are sacred and devoted to the burial of the dead.
- No visitor is permitted to carry or use tools in cemetery or do any work in the cemetery without the permission of the Board of Trustees or Supervisor.
- NO PETS shall be allowed in cemetery at any time.
- All visitors’ vehicles shall remain on drives and not park in the grass.
- All debris, discarded flowers or decorations shall be placed in trash containers.
- Artificial flowers may be placed on graves (in the grass) between November 1st and March 1<sup>st</sup>, ONLY.
- Visitors are not permitted to remove, cut, deface or destroy cemetery property.
- No hunting, fishing, geocaching or the like allowed.
- No firearms allowed on cemetery grounds.

**Section 3 – Resale of Lot By Individuals**

- A lot owner may dispose of his/her holdings to a second party by sale or transfer with the notification of the Supervisor. Lots can be sold only for the original purchase price or less. Byron Cemetery does not buy back lots after the original sale.
- Bath Township is committed to the health and safety of their employees and residents. It is the policy of Bath Township’s Byron Cemetery to remain open during most periods of inclement weather; however, there may be times when, due to weather conditions or other situations, Byron Cemetery may close.

**Article II – Interments**

**Section 1 – Burials**

- All in ground interments must be enclosed in an outer container (vault) per Byron Cemetery specifications.
- TOP SEAL/CONCRETE VAULTS ONLY! FLAT TOPS NOT PERMITTED!**
- Byron Cemetery permits ONLY cemetery employees to do the work of digging and covering graves for funerals. Under no circumstances will the general public or families be permitted to perform this work.
- All remains can be permanently memorialized at Byron Cemetery in a burial plot or mausoleum or columbarium.

- Only human remains will be interred in Byron Cemetery. (No pets or animal remains)

**Section 2 – Cremated Remains**

- Cremated remains in an urn may be buried in a grave space or in a cremation niche. Under no circumstances will the cemetery scatter human remains.
- Up to four cremains are permitted in a single burial space, each one incurring current Open & Close inurnment fee.
- Cremains inurned in a headstone will incur current Open & Close inurnment fee. Cremains inurned in headstone prior to delivery of headstone will incur half the price of current Open & Close inurnment fee.

**Article III – Decorations**

**Section 1**

- **Planting of trees, flowers and shrubs is strictly prohibited.**

**Section 2**

- Cutting and trimming grass is one of the largest and most costly maintenance activities of your cemetery. For economy of maintenance during growing season, (March 1<sup>st</sup> through November 1st) it is required that NO flowers or decorations may be placed in the grass, on top of graves or around the headstone foundations to allow for mowing and trimming.

**Section 3**

- The cemetery shall have the right to remove all floral designs, flowers and other decorations of any kind from the cemetery if, in the judgment of the Supervisor, they do not conform to the standards set forth herein.

**Section 4**

- The placing of decorations of any kind, with the exception of floral arrangements on monument or foundation, is highly discouraged for the safety of cemetery employees & visitors. Byron Cemetery is not responsible for any damage to such decorations.
- **Shepherds hooks, solar lights and eternal flames are not permitted unless installed in the concrete foundation out of the way of trimmers and mowers. They are not permitted to be stuck in the ground around the foundations.**

**Section 5**

- During mowing season decorations placed on the graves are permitted only for 5 days following holidays. The cemetery will remove any decorations left after this time so that maintenance can be performed. No exceptions.

**Section 6**

- Winter decorations, such as natural wreaths placed on easels and other approved arrangements such as grave blankets will be permitted from November 1st to March 1st.
- Winter decorations will be removed when they become unsightly.

**Section 7**

- Glass vases are strictly prohibited. All vases and urns must be securely fastened down to prevent the wind from blowing flowers around the cemetery.

**Section 8**

- Mausoleum/Columbarium Decorations:

1. Authorized Decoration shall mean: A photograph purchased and attached by a licensed and insured monument company; A Veteran Medallion issued by the Veterans Administration and installed by an authorized Byron Cemetery employee; A brass flower vase purchased through the Byron Cemetery and installed by an authorized Byron Cemetery employee; or Flowers placed in a purchased brass flower vase attached to the mausoleum/columbarium.
  2. Unauthorized Decoration shall mean any decoration that is not an Authorized Decoration. This includes, but is not limited to, the following: Balloons, streamers, or similar items attached, tied, or affixed to other items, including Authorized Decorations; Photographs, Veteran Medallions, and brass flower vases not installed by authorized individuals; and Flowers placed other than in a purchased brass flower vase attached to the mausoleum/columbarium.
  3. Authorized Decorations may be attached to the mausoleum/columbarium. No Unauthorized Decorations of any kind may be attached to or placed near the mausoleum/columbarium. All decorations under this section, whether authorized or unauthorized, shall be subject to Article III, Section 3.
  4. The Owner shall be financially responsible for any maintenance, including but not limited to, the replacement of any Authorized Decoration that has failed to remain attached to the mausoleum/columbarium or has deteriorated to the point where replacement is needed to prevent failure.
  5. Bath Township, the Bath Township Trustees, their employees, and divisions shall not be responsible for any damage caused by the installation, attachment failure, decoration failure, decoration mistreatment or overloading, or any other issue that may arise from the application of an Authorized Decoration to the mausoleum/columbarium.
  6. Flowers placed in a brass flower vase attached to the top row of the mausoleum/columbarium shall be placed using a tool provided by the Byron Cemetery.
  7. No stools, stepladders, ladders, or any other means of reaching the top row vases will be permitted.
- Oak Columbarium:** Inscriptions may include name, date of birth & death & appropriate epitaph. See cemetery office for more information.  
Decorations are permitted around the base of the mausoleum/columbarium only for 5 days following holidays.

**Article IV – Monuments**

**Section 1**

- Monuments over 36 inches in length & 6 inches tall must be on a foundation conforming to township specifications. No foot stones permitted except as a marker flush to the ground.

**Section 2**

- Only one grave marker shall be placed on any grave with the exception of VA markers. Additional markers for multiple interments are at the discretion of the Supervisor.

**Section 3**

- All foundations must be built by and in accordance with the specifications of the cemetery at the expense of the lot owner. No contractors or general public will be permitted to do concrete work. Most foundations (old section may be smaller) are 2’ x 4’ and require a 2” border between the base of the headstone and the edge of the foundation.
- No order for installation of a foundation may be acted on until specifications and certification of payment have been received.

**Section 4**

- Cemetery personnel may only receive delivery of a flat monument 36 inches in length & 6 inches tall or less for flush marker installation. All other monuments must be handled by insured monument companies only.

**Section 5**

- Temporary burial markers will be removed 30 days after interment during mowing season.

**Section 6**

- Niche Monuments are not permitted to be set until inurnment fee has been paid.

**Article V – Construction Work**

**Section 1**

- Monuments shall not be brought into the cemetery until all foundation work on the lot has been completed.

**Article VI – Lots & Grave Care**

**Section 1**

- The purchase price of your lot provides for regular care which includes such services as scheduled grass mowing, trimming, seeding, sodding and fertilizing and general maintenance of the cemetery. Owners cannot expect special or preferential treatment of their lots beyond such scheduled services.
